- 3. <u>Pre-Application Neighbor Notification, Difficult to Evacuate Sites and Sensitive Sites, Paragraph 21(c)(iv):</u> The parties will promulgate a mutually agreed-upon form to effectuate this term within 14 calendar days of the effective date of the Stipulated Agreement.

- 4. <u>Tarps, Paragraph 21(vi)</u>: Immediately upon the effective date of this Stipulated Settlement Agreement, TriCal will begin notifying affected parties regarding the requirements of this term. Within 45 days of the effective date of the Stipulated Settlement Agreement, TriCal will advise the Department regarding the status of implementing this term.
- 5. Observation of Chemigation Applications by Qualified Observer, Paragraph 21(d): Within 14 days of the effective date of the Stipulated Settlement Agreement, TriCal will provide the Department with a copy of a description of the job posting(s) required in order to staff the position of Qualified Observers.
- 6. Observation of Chemigation Applications by Qualified Observer, Paragraph 21(d)(i) (ix): Within 30 days of the effective date of the Stipulated Settlement Agreement the parties will promulgate a mutually agreed-upon form to effectuate this term.
- 7. Compliance Coordinator, Paragraph 21(e): Within 14 days of the effective date of the Stipulated Settlement Agreement, TriCal will provide the Department with a copy of a description of the job posting(s) required in order to staff the position of Compliance Coordinator for each and every Respondent (PCM License No. 30596, PCB License No. 38638 and PCB License No. 30597.) Within 30 days and 45 days of the effective date of the Stipulated Agreement, TriCal will advise the Department regarding the status of implementing this term.
