

This emergency rulemaking by the Department of Pesticide Regulation (the "Department") amends sections 6148, 6148.5, 6170, and 6216 in Title 3 of the California Code of Regulations. The Department is amending these sections to increase application fees for registration and renewal of each pesticide product from \$750 to \$1,150, and to change the application fee for label amendments from \$100 for amendments that require the support of data to \$25 for any amendment to a registered pesticide product. The increased application fees will ensure that the total collected revenue for the next three upcoming fiscal years is sufficient to support projected expenditure levels for the Department's pesticide registration program. Through this emergency rulemaking, the Department is also making non-substantive changes to the Application for Pesticide Registration.

OAL approves this emergency regulatory action pursuant to sections 11346.1 and 11349.6 of the Government Code.

This emergency regulatory action is effective on 10/1/2015 and, pursuant to Food and Agricultural Code section 12812, is a permanent emergency for which no Certificate of Compliance is needed.

TITLE 3. CALIFORNIA CODE OF REGULATIONS  
DIVISION 6. PESTICIDES AND PEST CONTROL OPERATIONS  
CHAPTER 2. PESTICIDES  
SUBCHAPTER 1. PESTICIDE REGISTRATION  
ARTICLE 1. GENERAL PROVISIONS

Amend section 6148 to read:

**6148. Fee for Each Product Submitted for Registration.**

(a) Effective October 1, 2015, ~~the~~ fee for each pesticide product submitted for registration is ~~\$750~~1,150. The fee applies to each:

- (1) New pesticide product;
- (2) Additional brand name of a pesticide product; and
- (3) Pesticide product where there is a change in business ownership of the product.

(b) If the Director returns an incomplete application for product registration to the applicant, the applicant has 180 days from the date the Director initially returned the application to resubmit a complete application without payment of a new registration fee. A new registration fee must accompany applications resubmitted after 180 days from the date the Director returned the application.

Note: Authority cited: Sections 12781 and 12812, Food and Agricultural Code.

Amend section 6148.5 to read:

**6148.5 Fees for Amendments to Registered Pesticide Products.**

(a) Effective October 1, 2015, ~~Each~~ application to amend the labeling or formulation of a registered pesticide product, ~~where the amendment must be supported by scientific data,~~ shall be accompanied by a fee of ~~\$400~~25. This fee does not apply to special local needs labeling.

(b) If the Director returns an incomplete application to amend the labeling or formulation of a registered pesticide product to the applicant, the applicant has 180 days from the date the Director initially returned the application to resubmit a complete application without payment of a new fee. A new fee must accompany applications resubmitted after 180 days from the date the Director returned the application.

## ARTICLE 2. REGISTRATION REQUIREMENTS

Amend section 6170 to read:

### **6170. Application.**

(a) Each application for registration of a pesticide product shall be made on the Application for Pesticide Registration Form ~~39~~ DPR-REG-030 (Rev. 9/03 10/15) ~~form, prescribed by the director~~ hereby incorporated by reference, and described in section 6170.5. The application is incomplete and may be returned by the Director if the application is not accompanied by the fee required by section 6148, six copies of the product labeling, and the data required to be submitted by sections 6159, 6170, 6172, 6176-6179, 6180(a), 6181-6192, and 6200 when applicable to support registration of the product. All data submitted by the applicant to the U.S. EPA in support of federal registration of the product shall be submitted and all studies shall be submitted in full. The product labeling should be printer's proof, final labels, or legible photocopies thereof. If typescript labels are submitted with the application, printer's proof, final labels, or legible photocopies thereof, must be submitted before a Certificate of Registration (License) for the product will be issued. If the label has been approved by a federal agency, proof of such approval shall be submitted with the application.

(b) An application to amend the labeling (including a special local needs labeling) of a pesticide product is incomplete and may be returned by the Director if the application is not accompanied by the fee required by 6148.5, six copies of the labeling and the data required to be submitted by sections 6159, 6170, 6172, 6176-6179, 6180(a), 6181-6192, and 6200 when applicable to the amendment. The application to amend the labeling shall be accompanied by all data submitted by the applicant to the U.S. EPA in support of the federal amended labeling of the product and all studies shall be submitted in full. The product labeling should be printer's proof, final labels or legible photocopies thereof. If typescript labels are submitted, printer's proof, final labels or legible photocopies thereof, must be submitted before the amended label will be accepted for use. If the amended labeling has been approved by a federal agency, proof of such approval shall be submitted with the amendment application.

(c) In lieu of submitting data pursuant to subsections (a) and (b) of this section, an applicant for registration or amendment may reference appropriate data previously submitted to the Director or a pesticide product(s) previously approved by the Director that would be subject to some or all of the same data requirements as applicable to the applicant's product.

(d) If an applicant does not submit or reference its own data to support its application for registration or amendment, it is subject to the requirements imposed under Food and Agricultural Code section 12811.5.


## ARTICLE 7. RENEWALS

### **6216. Annual Registration Renewal Fee.**

Beginning with those certificates of registration expiring on December 31, ~~2003~~ 2015, the fee for annual renewal is ~~\$750~~ \$1,150 for each product.

### PRODUCT INFORMATION

1. **Firm Name:** If federally registered, this must be the same as on file with U.S. EPA.
2. **Firm Mailing Address:** Correspondence, licenses, notices, etc. will be sent to this address.

### Certificate of Registration / Acceptance

If your product is registered, a Certificate of Registration (license) will be issued to you, authorizing sales for the remainder of the calendar year. Pesticide products may not be offered for sale until a Certificate of Registration has been issued.

If revised labeling is accepted for a registered product, the applicant will receive a letter of acceptance and a copy of the product labeling stamped "Labeling Acceptable.". All labeling to be used in connection with the sale of a product must be accepted by the Department of Pesticide Regulation, Pesticide Registration Branch, must accept all labeling to be used in connection with the sale of a product prior to sale or use of the product.

### Renewal of Registration:

In October of each year, you will be sent an Application for Renewal of Pesticide Registration, listing all currently registered products. To apply for renewal of these products, registrants must sign and return the form with the appropriate fee (\$1150750 per product). A penalty is assessed on all renewal requests received after ~~February~~ January 31. The renewal is Licenses will be renewed when the fees are processed by DPR and are not retroactive to January 1.

5. **Active Ingredient:** List each active ingredient in this formulation as it appears on the label. Please list all active ingredients from one source product together for ease of calculation of percentages.
6. **CAS No.:** The CAS Number may be obtained from the Chemical Abstract Service of the American Chemical Society, P.O. Box 3012, Columbus, Ohio, 43210. Microorganisms should be identified by ATCC (American Type Culture Collection) or other recognized type culture collection number.
7. **Name of Source Product:** The name of the product which provides that active ingredient in the formulation.
9. **Percent By Weight of Source Product in Formulated Product:** Each source product listed in Column #7 must have a value in Column #9.
