



## PUBLIC REPORT RELATING TO THE RENEWAL OF PESTICIDE PRODUCT REGISTRATIONS FOR 2007

Pursuant to Food and Agricultural Code (FAC) sections 12817 et seq., the Director of the Department of Pesticide Regulation (DPR) proposes to renew registrations for the calendar year 2007 of those pesticide products registered in 2006 (California Notice 2006-15).

FAC section 12824 provides that “All pesticides for which renewal of registration is sought...shall be evaluated in accordance with this section” and provides that DPR “shall develop an orderly program for the continuous evaluation of all pesticides actually registered.” To implement and interpret those provisions of FAC section 12824, DPR established the renewal and reevaluation process. Title 3, California Code of Regulations (CCR) sections 6215 and 6220-6226, respectively. Section 6215 requires applicants for renewal to submit a statement indicating that the applicant for renewal has complied with the adverse effects disclosure provisions of CCR section 6210. Section 6220 requires DPR to investigate all reports indicating that the use of a registered pesticide may have caused or is likely to cause a significant adverse impact to people or the environment. If, after investigation, DPR determines that a significant adverse impact to people or the environment has occurred or is likely to occur, DPR must reevaluate the pesticide involved.

The registrations of pesticide products are subject to renewal upon the registrant’s submission of prescribed fees and a statement that the registrant has complied with the adverse effects disclosure provisions of CCR section 6210, except when the Director, after hearing, has canceled the registration of, or refused to register, a pesticide product.

All pesticide products registered for use in California are a matter of public record and presently comprise a list of approximately 12,257 products. In 2006, DPR initiated one new reevaluation. On August 31, 2006, DPR placed certain pesticide products containing one or more pyrethroid active ingredients into reevaluation. This reevaluation is based on recent monitoring surveys and toxicity studies revealing the widespread presence of synthetic pyrethroid residues in the sediment of both agricultural and urban dominated California waterways at levels toxic to *Hyaella azteca* (*H. azteca*). For purposes of data requirements, DPR divided pyrethroid chemicals into three groups. The first group consists of the first generation or “Type I” photosensitive pyrethroids. Typically, these pyrethroids are used indoors and around residential areas. The second and third groups consist of the newer second-generation pyrethroids. These pyrethroids are less photosensitive, persist longer in the environment, and are widely used in both agricultural and urban settings. DPR is requiring registrants to submit environmental fate data, sediment data, and data/information relating to the reduction or elimination of offsite movement of pyrethroid residues. DPR did not conclude any

Applicants submit applications to register new pesticide products throughout the year. DPR reviews these applications for completeness and legal requirements. DPR scientists evaluate the complete applications and accompanying required data. DPR notifies other public agencies, which have jurisdiction by law over the use of pesticides or over activities, or resources, which may be affected by the use of pesticides when applications enter into the evaluation phase of the process. These agencies may review the information and data submitted, and raise concerns about the applications at any time, or at scheduled meetings of the Pesticide Registration and Evaluation Committee (PREC). PREC meetings are open to the public. Issues relating to pesticide use and effects are discussed at PREC meetings. In separate actions during 2006, the U.S. Environmental Protection Agency (EPA), pursuant to the Federal Insecticide, Fungicide, and Rodenticide Act, published notices regarding voluntary or other cancellation actions on pesticides or their use. These actions were published in the Federal Register throughout the year and are available through the U.S. Government Printing Office, at public libraries, or through the following Internet address: <<http://www.epa.gov/fedrgstr>>. DPR monitors such federal cancellation actions. Once the registrant sales of existing stock provisions allowed by EPA have expired the product can no longer be registered for sale or use in California.
