Hello,

I am pleased to welcome new faces and promotions at the Department of Pesticide Regulation. Each of them brings a combination of expertise, enthusiasm and inquiring minds which will greatly enrich our team. I will share more with you on these exciting changes later on.

**Firstly, I'd like to remind you that** DPR is embarking on an exciting period of growth and change. My focus is to transition away from the conventional pesticides and help to accelerate the development of more benign products and practices to control pests. At the same time we have to ensure that people who use pesticides do so in a manner that is protective of people and the environment.



**Strawberry Research:** Our partnership with the strawberry industry which is facing a fumigant crisis is a prime example of this. You may have seen recent news coverage of the action plan produced the by [Nonfumigant Strawberry Production Working Group](#). It is our road map to guide the research required to find production practices and tools necessary to maintain a viable **strawberry industry without fumigants. The Action Plan complements DPR's research** partnership with the California Strawberry Commission which is examining ways to grow strawberries in substance other than soil, with alternatives to fumigants.



**Pesticide Residue Monitoring:** Dozens of people recently joined us in the Sierra Hearing room at Cal/EPA and via a live webcast, to learn more about testing produce for pesticides. This successful brown bag lunch is part of our communications strategy to help keep staff aware of the many facets of DPR. Mike Papathakis, from DPR enforcement branch and Poonam Chandra (CDFA) put a great

deal of work into their presentations and kept the conversation and questions flowing. They helped to highlight the importance of this program. Well done to everyone who was involved in this tremendous effort and look at the photos on our [Facebook](#) page.



**Chloropicrin Outreach:** *The Ear* This summer DPR will be doing a lot of listening to its stakeholders as we propose mitigation measures designed to protect bystanders and residents from acute exposures to chloropicrin. As part of this effort, DPR will be holding a series of public meetings in June, that are designed to give us input from the public, growers and other interested parties. DPR will then consider all comments received, before finalizing the proposal. DPR will then initiate the process to implement the mitigation measures anticipated to be in effect the following year.
