A DPR representative will preside at the hearing. Persons who wish to make comments orally during the hearing may raise their hand using the Zoom functions and make oral comments when called upon. DPR requests, but does not require, that persons who make oral comments at the hearing also submit a written copy of their testimony via e-mail.

Oral comments presented at a hearing carry no more weight than written comments.

Any interested person may present comments in writing about the proposed action to the agency contact person named below. Written comments must be received no later than 5:00 p.m. on May 17, 2023.
