Dear Mr. Howland:

Thank you for your recent email to the Department of Pesticide Regulation (DPR) regarding the human health risk assessment and renewal status of glyphosate.

DPR is not conducting a human health risk assessment on glyphosate at this time. Until additional data become available, DPR will rely on the U.S. Environmental Protection Agency's (U.S. EPA's) assessment of the potential health risks from glyphosate exposure to determine if additional mitigation measures are necessary. If DPR initiates a human health risk assessment for glyphosate, a public notice will be issued and any additional information regarding the risk assessment will be made available at [https://www.cdpr.ca.gov/docs/whs/active\\_ingredient/glyphosate.htm](https://www.cdpr.ca.gov/docs/whs/active_ingredient/glyphosate.htm).

DPR is renewing all pesticide products that expired on December 31, 2017, and that were previously renewed for the year 2018, including products containing glyphosate.
