NOTICE OF DECISION TO BEGIN REEVALUATION OF PESTICIDE PRODUCTS CONTAINING DIAZINON

Pursuant to Article 8, Subchapter 1, Chapter 2, Division 6 of Title 3 of the California Code of Regulations, the Director of the Department of Pesticide Regulation (DPR) notices his decision to begin a reevaluation of pesticide products containing diazinon. Interested persons may comment on this decision up to and including the date shown on the top-right corner of this notice to the Department of Pesticide Regulation, Pesticide Registration Branch, 1001 I Street, P.O. Box 4015, Sacramento, California 95812-4015.

REEVALUATION

DPR is beginning a reevaluation of the pesticide products listed below. The products included in this reevaluation are agricultural use insecticides that contain the active ingredient diazinon.

BASIS FOR THE REEVALUATION

DPR initiates this reevaluation based on monitoring studies conducted between 1991 and 2001 by the U.S. Geological Survey, Dow Agrosiences, DPR, the California Regional Water Quality Control Board, Central Valley Region, and the State Water Resources Control Board. These studies demonstrate the presence of diazinon in the Sacramento and San Joaquin Valleys at levels that exceed the Department of Fish and Game's (DFG's) water quality criteria (WQC), especially during the dormant spray season. Pursuant to this reevaluation, diazinon registrants are required to: (1) identify the processes by which diazinon dormant spray products are contributing to detections of diazinon in surface water at levels that exceed DFG’s WQCs; and (2) identify mitigation strategies that will reduce or eliminate diazinon residues in surface water.
