He is the author of the Go Green Rating Scale for Early Childhood Settings and the Go Green Rating Scale Handbook; wrote the 40-hour Green Gardener Training Program Curriculum Guide; the 1994 EPA report Reducing Pesticides in Schools; and developed the Pesticide Hazard And Exposure Reduction Zone System, also called the PHAER (fair) Zone System.

Structural IPM—The Agurto brothers, Luis and Carlos, are the principal operators of Pestec, a SF Bay Area based integrated pest management firm. Together they have over 36 years of experience providing IPM services to municipal government, museums, schools, offices, and private and multi-unit residences.
