ABOUT THE PRESENTERS

Landscape IPM—Phil Boise has been helping school and park districts reduce their pesticide use for 20 years. From San Diego to New York City, Phil works at the ground level through innovation, collaboration, and demonstration. He is the author of the Go Green Rating Scale for Early Childhood Settings and the Go Green Rating Scale Handbook; wrote the 40-hour Green Gardener Training Program Curriculum Guide; the 1994 EPA report Reducing Pesticides in Schools; and developed the Pesticide Hazard And Exposure Reduction Zone System, also called the PHAER (fair) Zone System.

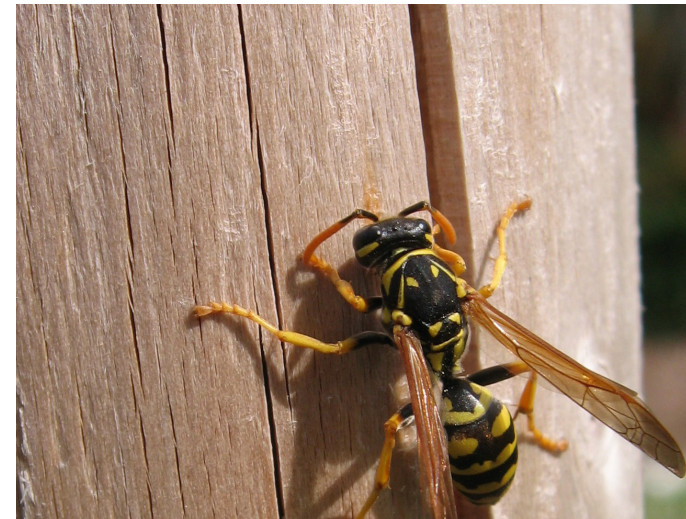
